2022 Brewery Safety Wrap-up and Preview of 2023

It is hard to believe that 2022 has come and gone, and we are swiftly moving into 2023. Our MBAA Brewery Safety Committee was very busy during 2022 developing tools and resources for our brewing community. We are looking forward to furthering our work in 2023 and supporting the brewing community with items that can help make your brewery operations safe and productive. There are several items from 2022 that we want to highlight, and a few things we want to share with you regarding the future endeavors of our committee.

OSHA Recordkeeping Posting Requirements

First, our committee wants to remind you of the OSHA recordkeeping requirements. If your Brewery had more than 10 employees in 2022, you must post your “signed” OSHA 300A summary log in a prominent place where employees can review it. The following rules apply:

- The log must be fully completed. (If there are no cases to report, you must place “0” in the respective columns.)
- A high-ranking company official must sign the log.
- The log must be posted from February 1, 2023, to April 30, 2023.

Electronic Reporting of Injury/Illness Data

Electronic reporting of your OSHA Form 300A data for calendar year 2022 is required unless one of the following apply to your business:

- The establishment’s peak employment during the previous calendar year was 19 employees or fewer, regardless of the establishment’s industry.
- The establishment’s industry is on [this list](#), regardless of the size of the establishment.
- The establishment had a peak employment between 20 and 249 employees during the previous calendar year, and the establishment’s industry is not on [this list](#).

Data reporting began January 2, 2023. The deadline for electronic reporting is March 2, 2023. You can find links for electronic reporting of injury/illness data on the [OSHA website](#), as well as a host of other great information concerning this topic.
