## 2021 Brewery Safety Wrap-up and Preview of 2022

It is hard to believe that 2021 has come and gone, and we are swiftly moving into 2022. Our MBAA Brewery Safety Committee was very busy during 2021 developing tools and resources for our brewing community. We are looking forward to furthering our work in 2022 and supporting the brewing community with items that can help make your brewery operations safe and productive. There are several items from 2021 that we want to highlight, and a few things we want to share with you regarding the future endeavors of our committee.

### OSHA Recordkeeping Posting Requirements

First, our committee wants to remind you of the new upcoming OSHA recordkeeping requirements. If your Brewery had more than 10 employees in 2021, you are required to post your “signed” OSHA 300A summary log in a prominent place where employees can review it. The following rules apply:

- The log must be fully completed. (If there are no cases to report, you must place “0” in the respective areas.)
- The log must be signed by a high-ranking company official.
- The log must be posted from February 1, 2022 to April 30, 2022.

### Electronic Reporting of Injury/Illness Data

Electronic reporting of your OSHA Form 300A data for calendar year 2021 is required **unless** one of the following apply to your business:

- The establishment’s peak employment during the previous calendar year was 19 employees or fewer, regardless of the establishment’s industry.
- The establishment’s industry is on this [list](#), regardless of the size of the establishment.
- The establishment had a peak employment between 20 and 249 employees during the previous calendar year **and** the establishment’s industry is not on this [list](#).

Data reporting will begin January 2, 2022. The deadline for electronic reporting is March 2, 2022.
